

Did You Know That There Are **Two**, Yes **TWO**, of You?

The Legal Person:

- **PERSON**. This word is applied to men, women and children, who are called natural persons. In law, man and person are not exactly-synonymous terms... 2. It is also used to denote a corporation which is an artificial person. "*person*" *Bouvier's Law Dictionary 1856*
- "**Persons**" are of **two kinds**, natural and artificial. A **natural person** is a human being. **Artificial [legal] persons** include a collection or succession of natural persons forming a corporation; a collection of property to which the law attributes the capacity of having rights and duties. (emphasis mine) *Black's Law Dictionary 4th Edition*.
- "The only legal person known to our form of law is the corporation, the body corporate." *Hague v. Cancer Relief & Research Institute, [1939] 4 DLR 191 (Man. K.B.)*
- Registering your child's birth is the first step to giving your baby a legal identity. Once your baby's birth is registered with the Province of Ontario, you will be able to apply for a birth certificate. <http://www.barrie.ca/LIVING/LICENSESANDPERMITS/Pages/BirthCertificates.aspx>

PERSON - "From 13th Century Latin persona = "the (fictional) legal character representing an individual HUMAN BEING or CORPORATION by CONSENT". Person is a key rule of Law describing a fundamental legal fiction—that is any individual or formal organization subject to the Curia (courts) or lesser courts. Providing consent is given without duress, legally an individual, a corporation and even a nation may be considered a PERSON and therefore subject to the principles of common law and commercial (maritime) law of the Vatican/Roman Cult. Legally, the name assigned to a Person must always be in CAPITALS to distinguish a "person" from a free man or free society." *Copyright 2010 UCADIA 2009. All rights reserved.*

The Trick Meaning of the legal term "**Includes**":

In all Acts and Statutes in Canada:

- "**person**", or any word or expression descriptive of a person, **includes** a corporation (emphasis mine) *Interpretation Act, R.S.C., 1985, c. I-21, section 35 "person"*
- "**person**" **includes** a corporation (emphasis mine) *Legislation Act, 2006 S.O. 2006, CHAPTER 21 SCHEDULE F, section 85, "person"*

Black's Law Dictionary, 6th Edition:

- "**includes**" "The inclusion of one is the exclusion of another. The certain designation of one person [type] is an absolute exclusion of all others. ... This doctrine decrees that where law expressly describes [a] particular situation to which it shall apply, an irrefutable inference must be drawn that what is omitted or excluded was intended to be omitted or excluded."

Yes, there are two—**TWO**—of you!

To know the difference you must give attention to the "*style*" of the name.

The Canadian Style, A Guide to Writing and Editing, written in co-operation with Public Works and Government Services Canada, on page 65 shows us the correct style for names:

4.03 Personal names


(a) Capitalize proper names and epithets that accompany or replace them:

John Diefenbaker

Peter the Great

Margaret Thacher

the Sun King



Now look at your Birth Certificate, Driver's Licence, vehicle Ownership(s), bank account(s), or any document you get from any level of government. How is the name written? As a *proper name* with one Capital letter as their manual requires, or as an *improper name* in all **CAPITAL** letters? Who, or what, is this other you?

Two different names, one—**John Diefenbaker** or **Margaret Thatcher**—is the proper name of a man or woman, the other is improper—**JOHN DIEFENBAKER** or **MARGARET THATCHER**, often written as **DIEFENBAKER JOHN**, or **THATCHER MARGARET**—is a legal "**person**" which the government created and attached to you.

If government created, and thereby owns, this legal "**person**," in its all caps "**NAME**" and this "**NAME**" is listed as the registered owner of your car, bank account, house, your children, etc... do you own anything?
